CANCER CARE

A Full-Circle of Compassion

Fourteen years ago, Dr. Chirag Patel was a young medical resident and new father, searching for answers when his infant daughter, Nala, was diagnosed with plagiocephaly, a condition that causes a baby's head to develop a flat or uneven shape. The care she received changed her future – but at the time, Dr. Patel had no idea that the innovator behind that care would one day change his.

That innovator was Jeanne Hertz, founder and CEO of Cranial Technologies. She would later be photographed with baby Nala for the cover of an Arizona magazine celebrating innovators and high-ranking women in business.

Since launching, the Lung Nodule Program has already **screened over 1,700 patients**, seen 500 in clinic, biopsied approximately 300 and **diagnosed more than 60 new lung cancers** – all at Stage I, when treatment is most effective.

More than a decade later, Dr. Patel – now a thoracic surgeon at HonorHealth – met Jeanne again, this time as her physician, after she was diagnosed with lung cancer. It wasn't until right before a Continuing Medical Education presentation – where Jeanne stood before over 100 community physicians – while reviewing Jeanne's credentials, that Dr. Patel realized she was the woman on the magazine cover he had saved for years – and the baby in her lap was his daughter.

As Jeanne and her husband, Frank, learned more about Dr. Patel's vision for early lung cancer detection, purpose emerged.

"When Jeanne first learned she had lung cancer, she knew she had been chosen for a reason," Frank says. "She realized she had the passion and the means to help fulfill a mission that could save lives."

Together, Jeanne and Frank committed a \$2 million gift to establish the Jeanne and Frank Hertz Thoracic and Cardiac Surgery Endowment, supporting HonorHealth's Lung Nodule Program. The program accelerates diagnosis, expands navigation and increases access to screening – especially for patients who might otherwise be overlooked.

The impact is already evident. Since launching, the program has helped diagnose dozens of patients with Stage I lung cancer, including a young, non-smoking woman whose journey from scan to surgery took just two and a half weeks.

Inspired by the Hertz family's generosity, their friends Jodi Pederson and Tim Beaudin have already contributed \$100,000 to the endowment.

Thanks to Jeanne's legacy, more patients will be diagnosed earlier, treated faster and given more time with the people they love. It is philanthropy at its most powerful – an investment whose impact comes beautifully, meaningfully, full circle.

IMPACT IN ACTION

HonorHealth Cancer Care

► HonorHealth sees 38% of breast surgery patients in metro Phoenix, more than any healthcare system in Arizona. Your generosity launched an expansion of HonorHealth Cancer Care, bringing the breast health team together under one roof, improving outcomes through clinical collaboration.

► While patients may still experience some hair loss during cancer treatments, we empower them to manage their side effects and thrive during and after therapy. The kindness and compassion of donors recently provided them with a revolutionary, FDA-cleared, scalp cooling technology that helps maintain their hair follicles. By cooling the scalp to approximately 65 degrees, the technology limits chemotherapy absorption in hair follicles, helping to preserve hair.

► Your generosity has increased lung cancer treatment options and improved patient outcomes. HonorHealth Research Institute is improving treatments in gene therapy, early drug and device development, early detection and prevention. Through our clinical trials and applied research, we've given hope and improved the lives of patients from all 50 states and 28 different countries around the globe.

Understanding the Need

More people are facing cancer, too many without equal access to care – and the need for integrated treatment and research continues to grow

► Maricopa County's population is expanding rapidly, which directly increases the number of cancer diagnoses. More than 45% of cancer patients in the county receive at least part of their treatment at HonorHealth, underscoring the strain on local oncology services. With more than 41,000 new cancer cases expected annually in Arizona, sustained funding is needed to meet demand for diagnosis, treatment and support.

► Low-income, uninsured and underinsured patients face significant barriers to timely and effective cancer care. These groups are more likely to present with late-stage disease, leading to poorer survival rates.

► HonorHealth's Virginia G. Piper Cancer Center focuses on integrating diagnosis, treatment, clinical trials and survivorship. These services require ongoing investments in technology, staffing and research to stay at the forefront of cancer care.

Lucking Family Distinguished Chair

A Historic Gift That Will Shape the Future of Medicine in Arizona

What began as an unexpected turning point has become a legacy of hope. Years ago, after a serious accident on an Antarctic glacier, John Lucking was rushed home to Phoenix and into the ICU at HonorHealth's John C. Lincoln Medical Center. The compassionate care he received forged a bond between the Lucking family and HonorHealth—one that deepened as John later joined the HonorHealth Foundation Board of Trustees.

In 2025, that journey came full circle.

John and Pit Lucking made a transformational \$5 million gift to establish the Lucking Family Distinguished Chair in Medicine – the first endowed chair in HonorHealth's history. Their investment marks a milestone moment for our community, elevating HonorHealth's commitment to academic medicine, research and the training of tomorrow's physicians.

Endowed chairs are among the most prestigious forms of support in academic medicine. They help attract and retain top talent, accelerate research, and strengthen training for future physicians – including students of Arizona State University’s new John Shufeldt School of Medicine and Medical Engineering, where HonorHealth serves as the primary clinical affiliate.

For Arizona, the impact is timely and urgent. With our state facing a severe provider shortage in the coming years, the Lucking family’s gift helps build a sustainable pipeline of skilled physicians who will care for our communities for generations.

The Luckings’ leadership launches a new era for HonorHealth Foundation’s Patrons of Promise initiative, an endowed-chair matching challenge designed to expand academic medicine and accelerate innovation across our system.

Their generosity sets the stage for the future and lights the way for others to follow.

THE NEED

Academic Medicine

Endowed chairs dramatically increase educator credibility and long-term impact

A study of endowed chairholders in academic medicine found that 96% reported lasting gains in visibility, credibility, mentoring capacity and institutional impact – effects that continued long after their term ended.

Academic medicine is a major engine of lifesaving research

Research conducted by academic medical professionals has contributed to significant national health gains. For example:

- A 56% reduction in heart attack deaths between 1999-2020
- 3.8 million lives saved through advances in cancer research since 1991

Arizona faces one of the nation’s most urgent provider shortages – underscoring the need for academic investment

Arizona currently meets only 40% of its primary care physician need and will require 1,941 additional PCPs by 2030 to keep pace with demand.

Finding Answers, Restoring Hope

In July 2024, a young mother's life unraveled as her body began to fail her without warning. Her heart raced. Her blood pressure spiked and crashed. She lost consciousness and, at times, couldn't eat, drink or keep medications down. After countless emergency room visits, tests and specialist appointments, no one could explain what was happening. Fear and exhaustion set in, and Chalet's hope began to fade.

That changed when she was referred to HonorHealth's Whole Health Institute. From her first visit, Chalet felt something she hadn't in months – she was truly

heard. Dr. Shalini Singh-Karnick, HonorHealth Integrative Medicine specialist, listened closely to every symptom, fear and connection others had dismissed. When Chalet shared her belief that her episodes were linked to her menstrual cycle, the care team followed that insight. Working collaboratively with Dr. Suzanne Bartlett Hackenmiller, HonorHealth Integrative Medicine specialist, they ordered the right tests and uncovered the answer: polycystic ovary syndrome (PCOS).

With a clear diagnosis came a personalized, whole-body care plan. Through nutrition

counseling, lifestyle changes, integrative therapies and targeted medical treatment, Chalet began to heal.

"I'm a better mom, a better wife and better employee," she says. "Having a name for what was happening was empowering. I owe Drs. Singh-Karnick and Hackenmiller everything – they gave me my life back."

She adds, "So many women are dismissed or told it's 'just anxiety.' Integrative medicine gave my kids their mom back. Your donations truly give life."

Building a Longer, Healthier Future — Together

Blue Zones is a community-led well-being initiative rooted in research from global longevity hotspots, designed to make healthy choices easier through lasting environmental change. HonorHealth is uniting civic, business and community leaders in the City of Scottsdale to launch a multi-year effort to become Arizona's first Blue Zones certified community.

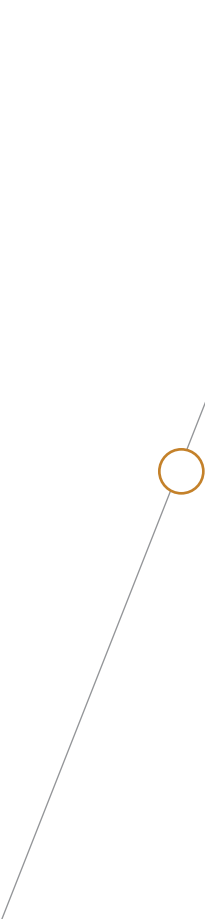

Finding Light Again at Desert Mission

For nearly 50 years, Kevin and Marie Hughes have walked hand in hand through life – raising nine children, weathering challenges and celebrating decades of love. But when Kevin was diagnosed with dementia, that life began to narrow.

A proud military veteran who once served as a military police officer across the U.S. and overseas, Kevin had always been steady and independent. After his diagnosis, that confidence slowly slipped away. His world grew quieter. Days once filled with purpose gave way to isolation – too much television and sleep, and little connection beyond home.

“He became isolated and depressed,” Marie recalls. “There just wasn’t anything to stimulate him anymore.”

For Marie, a retired nurse of more than 30 years, the shift was heartbreaking. Overnight, she became not only a wife, but a full-time caregiver. She was constantly on alert and constantly worried. Kevin no longer recognized his own limitations, and Marie lived with the fear that he might wander, get hurt or decline faster.

“I was burned out when we got here,” she admits. “And that was scary.”

That’s when the Hughes family found Adult Day Health Care at HonorHealth Desert Mission, a program made possible in large part by the generosity of donors who believe deeply in compassionate, community-based care.

Kevin didn’t want to go at first.

“I didn’t think I’d like it,” he says with a laugh. “I thought it would just be a bunch of people sitting around.”

On his first day, Kevin met Rob – another participant who rode the same bus. Rob greeted him with warmth and friendship. Soon, Kevin met more friends, some of them fellow veterans, all of them welcoming. Slowly, almost without realizing it, Kevin found his place.

Today, Kevin calls the program “school.” He looks forward to going. He talks about his friends. He prays for them when they’re sick. He lights up when he tells Marie stories about ceramic projects, travel shows he watches with other participants and the staff members who treat him not as a patient, but as a person.

Through daily structure, meaningful activities, companionship and clinical support, the program helped restore something Kevin had lost: a sense of dignity and belonging.

The impact has been remarkable. Kevin is more engaged. He sleeps and eats better. His health has improved so much so that he no longer requires medication for depression and has seen significant improvements in his diabetes management. Just as important, he no longer feels alone.

For Marie, the transformation has been equally profound.

"I know he's safe," she says. "I can run errands; I can go to the gym or read a book. I can just rest."

That respite – the ability to be Marie again, not just "the caregiver" – is priceless.

"You lose yourself when someone you love has dementia," she explains. "This place gives a piece of me back."

The Hughes family has now been part of the Desert Mission community long enough that staff members know their story, their children, their worries and their hopes – including Kevin's deepest wish: to celebrate their 50th wedding anniversary this August.

"This place gave us hope again," Marie says.

Programs like Adult Day Health Care at HonorHealth Desert Mission exist because donors choose to invest in people at some of the most vulnerable moments of their lives.

"You can't put a price on dignity," Marie says. "And you can't put a price on lifting that weight off a caregiver's shoulders."

Because of donor support, Kevin found friendship, purpose and joy again.

Because of donor support, Marie found relief, strength and peace.

And because of donor support, a family found light when they needed it most.

A Better Option When It Matters Most

At 87 years old, May was living with constant abdominal and rectal pain that severely limited her quality of life. Her physician identified the cause: a large rectal polyp so advanced that it had begun protruding from her body – an urgent and complex condition requiring specialized care.

May was referred to HonorHealth colorectal surgeon Dr. Andrew Kassir. Given her age, traditional open surgery carried significant risks and likely would have left her dependent on a permanent colostomy bag. Instead, Dr. Kassir recognized that May could benefit from a far more advanced – and far less invasive – approach: interventional endoscopy.

She was referred to Dr. Amar Thosani, a gastroenterologist at the HonorHealth Center for Interventional Endoscopy, where leading-edge procedures offer alternatives to major surgery. After conducting an endoscopic ultrasound to rule out early cancer, Dr. Thosani selected his colleague Dr. Cris Pitea, to perform an endoscopic submucosal dissection – a highly specialized procedure available at only a limited number of centers nationwide and requiring exceptional expertise.

The outcome was life-changing.

Today, at 91, May has recovered fully. She avoided open surgery, prevented the need for a permanent colostomy and has experienced no recurrence of her condition – all because she had access to advanced interventional endoscopy.

This is the power of donor-supported innovation. Philanthropy makes it possible to recruit highly specialized physicians, invest in advanced technology, and offer lifesaving – and life-preserving – procedures that restore independence and dignity for patients like May.



THE NEED

HonorHealth Interventional Endoscopy

**Interventional Endoscopy saves lives
and preserves quality of life**

- Advanced endoscopic techniques can remove large or complex polyps before they become cancer, often eliminating the need for major surgery.
- Studies show patients treated with endoscopic mucosal resection for eligible colon lesions had significantly lower mortality and less health care utilization than those undergoing surgery.
- More than 3,300 Arizonans are diagnosed with colorectal cancer each year.
- Arizona is one of 15 states without a CDC-funded colorectal cancer screening program, increasing reliance on advanced treatment once disease is discovered.

Where Philanthropy Saves Lives: A Family's Journey Through Coordinated Care

Philanthropy fuels the innovative technologies behind today's minimally invasive heart procedures, making them safer, faster and more accessible. Donor generosity also helps HonorHealth attract and retain world-class physicians dedicated to delivering coordinated, patient-centered care – support that made all the difference for Mark Steel.

In 2019, Mark – an American Red Cross volunteer for nearly a decade – became unexpectedly winded while lending his technology expertise in the aftermath of the Camp Fire in Paradise, California. His vital signs appeared normal, but he sensed something wasn't right. Back home, he began a diagnostic journey that ultimately led him to Dr. Maulik Shah, executive director of HonorHealth Heart Care.

Stress testing quickly revealed the need for urgent intervention. Within days, Mark received four stents placed through the wrist, resulting in immediate improvement.

"Dr. Shah saved my life," he reflects. "It could've gotten very serious, very quickly."

Mark's appreciation deepened in early 2023, when his mother, then in her mid-90s, required urgent, highly coordinated care. Following a failed hip repair, she required a full hip replacement, but her heart wasn't strong enough to undergo the procedure. She first needed an aortic valve replacement. The surgeon's office told the family the next available appointment was months away – time they simply didn't have.

When they relayed this to Dr. Shah, he secured a next-day appointment for a minimally invasive transcatheter aortic valve replacement (TAVR) at HonorHealth.

The family was assigned a dedicated nurse to guide them through scheduling and to facilitate coordination between the doctors and care teams for the upcoming procedures. Within a matter of weeks, Mark's mother received both the valve replacement and the hip replacement, coming through both with flying colors.

Although she recently passed away at age 99, Mark credits the collaborative, solutions-driven care she received at HonorHealth with eliminating her pain and improving the quality of her final years.

"The coordination was unprecedented," he says. "I have more respect for Dr. Shah and HonorHealth than I've ever had for a medical establishment. I am forever grateful."

Today, Mark continues to refer friends and neighbors to Dr. Shah, filled with gratitude for the care that transformed two lives.



Hope Reaches the Heart

Philanthropy powers innovation at HonorHealth, and heart care is a leading example. Donor generosity enables investment in advanced technology, research infrastructure and exceptional physicians—allowing our teams to deliver safer, minimally invasive treatments to patients with complex cardiovascular disease.

In late 2024, HonorHealth became the first non-clinical trial site in Arizona to perform a transcatheter tricuspid valve replacement using the FDA-approved EVOQUE system from Edwards Lifesciences. The procedure was led by a multidisciplinary team that included Dr. Haidar Yassin, network director of structural heart disease, whose expertise and advocacy helped bring this breakthrough technology to HonorHealth.

The program quickly gained national attention. In 2025 alone, the team completed more than 30 additional procedures, including some of the most complex cases worldwide. One patient – previously in heart and liver failure and considered inoperable – ran a marathon just seven months after treatment, demonstrating the life-changing impact of donor-supported innovation.

Building on this momentum, HonorHealth was granted access to two next-generation transcatheter mitral valve replacement (TMVR) systems, including Edwards Lifesciences' SAPIN M3. HonorHealth is now one of only nine hospitals nationwide with access outside a clinical trial. Philanthropic investment in research also supported eight years of testing at HonorHealth Research Institute for Abbott's Tendyne™ TMVR system prior to FDA approval in 2025.

"These milestones reflect both our clinical excellence and the trust placed in HonorHealth by leading medical technology partners," says Dr. Yassin. "My goal is to make HonorHealth a destination for structural heart innovation – so even when I'm not directly treating patients, I'm still helping care for them."

With donors as partners, HonorHealth will continue advancing heart care, expanding access to groundbreaking therapies and bringing renewed hope to patients in our community and beyond.



INNOVATION ENDOWMENT

Advancing Clinical Care Through Innovation

Regenerative medicines, futuristic technologies and other amazing advancements offer solutions that were unthinkable just a few years ago.

Our mission is clear: to improve the health and well-being of those we serve. Yet in the rapidly evolving world of medicine, fulfilling that mission demands more than dedication; it requires innovation.

The HonorHealth Innovation Endowment in clinical care bridges the gap between what traditional healthcare funding covers and what the future of medicine demands.

Through philanthropy, these are a few of the programs we're bringing to life at HonorHealth:

Ambient Voice Technology

► An advanced, AI-powered voice recognition technology that listens in on clinical encounters to automate medical transcription. It enables physicians to surface important information, allowing them to focus intently on their patients.

Large Language Models

► A type of AI technology that assists clinicians to make diagnoses, interpret test results and identify potential clinical trial opportunities. By scrutinizing patient records, LLMs suggest treatment plans tailored to an individual's medical history and specific needs.

Epic Cosmos

► A community collaboration that allows health systems to gain insights and make discoveries from their combined data created by providing care to more than 200 million patients. It anonymizes patient information, providing tools for researchers and delivering insights to clinicians.

HonorHealth/CDW Transformation Center

► Thanks to a generous gift from CDW Healthcare Solutions, the HonorHealth/CDW Transformation Center is testing solutions to healthcare challenges in a controlled, simulated environment. These innovations have the potential to transform healthcare delivery worldwide.

Powered by Giving, Led by Nurses

When Chastine Elam steps onto her nursing unit at HonorHealth Deer Valley Medical Center, she brings more than clinical expertise – she brings confidence, compassion and a belief that healing means helping patients move forward, even when it’s difficult.

A registered nurse in trauma care, Chastine’s calling was shaped early on. Growing up in Phoenix, she spent hours in hospitals supporting her sister through medical challenges. It was the nurses’ steady presence and compassion that left a lasting impression.

“I always loved nurses,” she says. “They were the ones who made hard moments feel manageable.”

Today, Chastine provides that same reassurance to her patients.

Through the Nursing Excellence Endowment, funded by generous donors, Chastine received support to attend the American Nurses Credentialing Center’s Magnet & Pathway Conference in 2025. The experience exposed her to national best practices and innovations, but more importantly, it reshaped how she saw her role as a nurse.

“It made me realize nursing is so much bigger than the bedside,” she shares. “What we do has purpose beyond the moment.”

She returned to her unit energized and ready to lead. Chastine shared insights from the conference with colleagues, encouraged research and collaboration, and became a trusted resource for strengthening communication across care teams.

“It gave me the confidence to speak up and be involved,” she says.

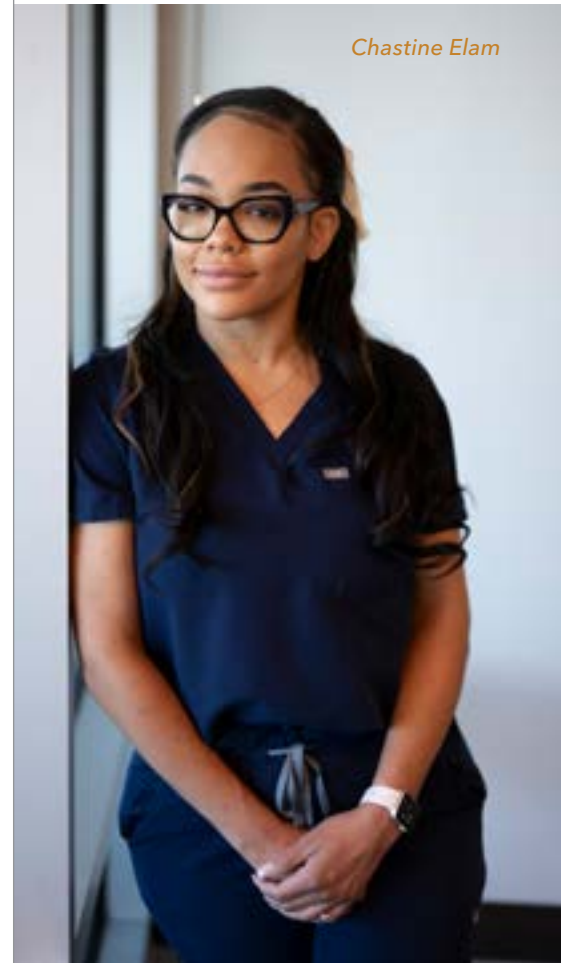
That confidence now shows most clearly in her patient care. Many of her trauma patients face fear and uncertainty as they work to regain mobility after serious injuries. Chastine is a strong advocate for helping them take that first step forward – physically and emotionally.

“They think they can’t do it,” she explained. “And then they stand, move, and you see that relief and pride.”

With encouragement, compassion and thoughtful determination, she empowers patients to believe in their own recovery – an approach strengthened through donor-supported leadership development.

Through investments in nursing excellence, donors are not only supporting education, they are strengthening leadership, elevating care and helping patients move forward with confidence, one step at a time.

A Life Reclaimed

KETTY'S STORY OF HOPE THROUGH RESEARCH

Ketty Fessahazion doesn't look like someone living with ovarian cancer.

Thanks to care received through a clinical trial at HonorHealth Research Institute, the 42-year-old Glendale financial executive lives an active, full life – with little reminder of the disease she carries.

"Thankfully, I've had very few symptoms, if any at all," Ketty says. "If nobody told me, I wouldn't know I had cancer. My energy level is great. I live my life normally. This is just one part of it."

In 2013, Ketty developed a persistent cough and shortness of breath. Tests revealed late-stage ovarian cancer, including a tumor on her left ovary and two liters of fluid in her lungs. She underwent a full hysterectomy, followed by chemotherapy and radiation, but the cancer spread to her lymph nodes. By 2019, those treatments were no longer working and Ketty was told she had exhausted her options.

Hope returned in 2020, when she was referred to HonorHealth Research Institute and enrolled in a clinical trial led by Dr. Erkut Borazanci, medical director of the Institute's Cancer Research Division.

Like many patients, Ketty had concerns about research. But those fears quickly faded when she was met with warmth and empathy. "Dr. Borazanci already had two treatment plans prepared. That showed me they truly cared about me and my future," she says.

The trial worked. Ketty's cancer is now managed as a chronic condition, allowing her not only to survive, but to thrive. With her disease under control and approval to continue on the trial, Ketty made a life-changing decision: she stepped away from her corporate career to pursue work rooted in purpose.

She launched She Is Limitless Coaching, a business focused on helping women identify their values, challenge limiting beliefs and establish healthy boundaries. She also founded Sweet Dreams Angels Foundation, a nonprofit that helps low-income families cover funeral expenses after losing a child to illness.

Because of research – and the generosity that fuels it – Ketty is not only living well with cancer, she is building a legacy of compassion, resilience and hope for others.
